



CONTEST RULES

1. CONTEST ORGANIZER

This contest is being held by TOHU, la Cité des arts du cirque.

2. CONTEST DATES

The contest runs from June 20th to July 9th, 2008 at 11:59 pm.

3. HOW TO SIGN UP

- Inscribe you to the La TOHU Newsletter (e-bulletin) by filling in the on-line form available at www.tohu.ca/contest. People having already subscribed to the La TOHU Newsletter can also participate, simply by filling in the same form.
- The participant gets a chance to win a (1) **La TOHU's VIP PRIZE** to assist *La Vie* media première, a circus show by The 7 Fingers (Quebec), presented at La TOHU on Wednesday September 24th, 2008, at 8 pm.
- The participant can also get more chances to win by inviting friends (max. 5) to participate to this contest (one friend invited = one extra chance). Each friends' e-mail must be valid to be accepted.
- The chances of winning the prize depend on the number of subscriptions to the contest and on the number of friends invited.
- No purchase is required.

4. CONTEST PRIZE
